Chinese food supplement manufacturers learn from Diapharm in Frankfurt

Frankfurt (DE), 13. November 2019 – A delegation from the China Chamber of Commerce for Import and Export of Medicines and Health Products (CCCMHPIE) visited Diapharm's location in Frankfurt to learn about European market requirements for food supplements and food for special medical purposes. "We must always emphasise that even though we have a harmonised food legislation for 'the European market'," says Ralf Sibbing, Managing Partner at Diapharm. "every country in Europe has its own interpretation and particular characteristics in terms of its implementation, but these also create special opportunities." On their trip to Europe, the delegation also visited Switzerland and Norway as well as Germany.
